

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.nCloudIntegrators.com, and nCloud Integrators and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to nCloud Integrators include www.nCloudIntegrators.com. The nCloud Integrators website is used to market our services, which may include: Software Implementation Services, Custom Training & Consulting Services. By using the nCloud Integrators website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, nCloud Integrators may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

nCloud Integrators may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

nCloud Integrators collects and uses your personal information to operate and deliver the services you have requested.

nCloud Integrators may also use your personally identifiable information to inform you of other products or services available from nCloud Integrators and its affiliates.

Sharing Information with Third Parties

nCloud Integrators does not sell, rent or lease its customer lists to third parties.

nCloud Integrators may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. - Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
